- On 2 July 2020, an aggregate of 2,500,000 2015 Preference Shares (as defined below) were redeemed by South China Holdings Company Limited (the "Company") at the price of HK\$0.80 per 2015 Preference Share according to the terms of the 2015 Preference Shares. Hence, the total amount of the 2015 Preference Shares decreased by HK\$2,000,000.00 and became HK\$293,880,504.80 at the close of July 2020.
- Notwithstanding the restrictions on conversion of the redeemable convertible preference shares, which were issued on 7 October 2015, ("2015 Preference Shares") as disclosed in the circular of the Company dated 4 September 2015 that ordinary shares will be issued upon the conversion of the 2015 Preference Shares at the conversion price of HK\$0.40 at the initial conversion rate that one (1) 2015 Preference Share to two (2) ordinary shares according to the terms of the 2015 Preference Shares, 734,701,262 ordinary shares will be issued on the assumption of full conversion of the remaining 2015 Preference Shares at the close of July 2020.
