DISCLOSEABLE TRANSACTION FURTHER DISPOSAL OF THE DEBENTURE AND MEMBERSHIP

On 24 May 2022 (after trading hours), the Vendors entered into the Sales and Purchase Agreement with the Purchaser, pursuant to which the Purchaser has agreed to purchase and the Vendors have agreed to sell the Debenture and Membership at the consideration of HK\$4,240,000.

As the applicable percentage ratio(s) for the Second Disposal does not exceed 5% on a stand-alone basis, the Second Disposal is not subject to disclosure requirements under Chapter 14 of the Listing Rules.

As one of the applicable percentage ratios under Rule 14.07 of the Listing Rules in respect of the Second Disposal, when aggregated with the Previous Disposals, exceeds 5% but is less than 25%, the Second Disposal together with the Previous Disposals constitutes a discloseable transaction of the Company under Chapter 14 of the Listing Rules.

Reference is made to the announcement of the Company dated 24 March 2022 in relation to the disposal of the debentures and memberships of the Club.

The Board announces that on 24 May 2022 (after trading hours), the Vendors entered into the Sales and Purchase Agreement with the Purchaser, pursuant to which the Purchaser has agreed to purchase and the Vendors have agreed to sell the Debenture and Membership at the consideration of HK\$4,240,000.

- (a) a deposit in the sum of HK\$1,272,000 shall be paid on the date of signing of the Sale and Purchase Agreement; and
- (b) the balance of the consideration in the sum of HK\$2,968,000 shall be paid within five (5) Business Days after the date of receipt of the notification from the Club or the Purchaser (as the case may be) by the Vendors that the approval for the Purchaser's application for the transfer of the Debenture and Membership has been granted by the Club

INFORMATION ON THE COMPANY, THE FIRST VENDOR, THE SECOND VENDOR, THE THIRD VENDOR AND THE PURCHASER

The Company

The Company is an investment holding company. Its principal subsidiaries are engaged in the manufacturing and trading of toys, electronic toys, shoes and leather products, property investment and development, agriculture and forestry businesses.

The First Vendor

The First Vendor is a company incorporated under the laws of the British Virgin Islands and an indirect wholly-owned subsidiary of the Company, which is the beneficial owner of the Debenture and Membership. It is principally engaged in investment holding.

The Second Vendor

The Second Vendor is a company incorporated in Hong Kong with limited liability and a wholly-owned subsidiary of a substantial shareholder and director of the Company. It disposed of a number of marina debentures and memberships of the Club to various wholly-owned subsidiaries of the Company, including the First Vendor, in 1993, and acts as a

trustee together with the Third Vendor being a registered owner of all such marina debentures and membership for all such wholly-owned subsidiaries of the Company for facilitating the sale of all such marina debentures and memberships.

The Third Vendor

The Third Vendor is a company incorporated in Hong Kong with limited liability and an Independent Third Party. It is principally engaged in investment holding and in its own name holding a number of debentures and memberships of the Club as a trustee together with the Second Vendor for various subsidiaries and affiliates of the Company for facilitating the sale of all such debentures and memberships.

The Purchaser

The Purchaser is a Hong Kong resident, being an Independent Third Party.

REASONS FOR AND BENEFITS OF THE SECOND DISPOSAL

The Debenture and Membership have been beneficially owned by the Group since 1993 and its carrying value as at 31 December 2021 was about HK\$1,412,000.

As a result of the Second Disposal, the Group is expected to recognize a gain of approximately HK\$2,828,000 (before taxation and without deduction of expenses related to the Second Disposal), which is calculated based on the difference between the carrying amount of the Debenture and Membership as at 31 December 2021 and the consideration of the Second Disposal before any related expenses. Shareholders should note that the actual gain on disposal to be recorded by the Company will depend on the actual book value of the Debenture and Membership as at the date of Completion of the Second Disposal.

The Company intends to use the proceeds from the Second Disposal as general working capital of the Group.

Taking into account of the current financial position and business operation of the Group, the Board believes that the Second Disposal is a good opportunity for the Group to realise the value of the Membership and the Debenture at a reasonable price and the proceeds from the Second Disposal will improve the financial position and increase the general working capital of the Group.

The Board considers that the Second Disposal and the terms of the Sale and Purchase Agreement have been made on normal commercial terms and are fair and reasonable and are in the interests of the Company and the Shareholders as a whole.
